The Village Board of Trustees and I hope that you are well and are weathering these uncertain times. We are all being affected by the COVID-19 virus, whether it is from school closings, working from home or searching the internet for home supplies. It is times like this that we can pull together and support one another. If you need assistance, please contact the village or me. My cell: 516.987.8203. I have included below some important contact information for the Villager residents and also some adjustments to our schedule.

The Old Brookville Police Department is well manned and ready to assist with your needs. The phone number for our dispatch professionals is 516.626.1300. If you dial 911 for a medical or other emergency from your cell phone that call will go to Nassau County dispatch and they in turn will contact the OBPD. If you are in your home and dial 911 from a land line, that call will go directly to our dispatchers – saving a step.

If you are in need of the Fire Department, the same procedure applies – please call 911

In an effort to be medically cautious, our Building Department will not be accepting “walk-in” appointments until further notice. In the future we will review the state of this medical emergency and make a determination as to whether to continue the policy. The Building Inspector will continue to make site inspections on a case by case basis.
